

**MINUTES

SPECIAL CITY COUNCIL MEETING
MAY 17, 2010**

Mayor David W. Samuelson declared a Special Meeting duly open for the transaction of business at 6:04 p.m. Councilmember Domingo Montalvo, Jr. led the opening devotion and then Mayor led the pledge of allegiance.

Councilmember's present were: Mayor David W. Samuelson, Councilmembers, Lewis Fortenberry, Jr., Terry David Lynch, Don Mueller, Domingo Montalvo, Jr. and Jeff Gubbels

Councilmember absent was: V. L. Wiley, Jr.

Staff members present were: City Manager Andres Garza, Jr., City Secretary Lisa Olmeda, and City Attorney Paul Webb.

Visitors present were: Barry Halvorson with Wharton Journal Spectator.

The second item on the agenda was Roll Call and Excused Absences. Councilmember Domingo Montalvo, Jr. made a motion to excuse the absence of Councilmember V. L. Wiley, Jr. from the special City Council meeting held on May 17, 2010. Councilmember Lewis Fortenberry, Jr. seconded the motion. All voted in favor.

The third item on the agenda was Public Comments. No comments were given. No action was taken.

The fourth item on the agenda was to review and consider an ordinance canvassing the election returns and declaring the results of the City Officers' Election held May 8, 2010.

BE IT RESOLVED by the City Council of the City of Wharton, Texas:

The City Council of the City of Wharton, Texas has canvassed the returns of the city officers' election held on the **8th of May 2010**, and the City Council finds and declares that the election returns were duly and legally made, that all of the votes counted at the election were valid and legal, and that each of the candidates in the election received the following numbers of votes:

Mayor David W. Samuelson presented the Certificate of Election to elected Mayor Domingo Montalvo, Jr., Councilmembers Lewis Fortenberry, Jr., Don Mueller and Jeff Gubbels.

The fifth item on the agenda was to review and consider a resolution of the Wharton City Council approving a Letter of Engagement between the City of Wharton and Andrews Kurth LLP for bond counsel services and authorizing the City Manager of the City of Wharton to execute the agreement. City Manager Andres Garza, Jr. stated that during the May 10, 2010 Wharton City Council meeting, the City Council approved the City Staff to move forward with refunding bonds; however, Mr. Thomas A. Sage, the City's bond counsel had partnered with Andrew Kurth, L.L.P. and was no longer with Vinson & Elkins. He then presented a copy of the letter received on May 14, 2010 from Mr. Sage regarding the change in firms. He said that Mr. Sage's team prepared a Letter of Engagement for bond counsel services. He then presented a draft copy of a resolution approving the City Manager to execute the letter of agreement, which was required to move forward with refunding the bonds. After some discussion, Councilmember Don Mueller made a motion to approve Resolution No. 2010-27, which read as follows:

A RESOLUTION OF THE WHARTON CITY COUNCIL APPROVING A LETTER OF ENGAGEMENT BETWEEN THE CITY OF WHARTON AND ANDREWS KURTH,

LLP FOR BOND COUNSEL SERVICES AND AUTHROIZING THE CITY MANAGER OF THE CITY OF WHARTON TO EXECUTE THE AGREEMENT.

WHEREAS, the City of Wharton wishes to engage the services of Andrews Kurth, LLP for bond counsel services; and

WHEREAS, Andrews Kurth, LLP wishes to provide the City of Wharton with bond counsel services; and

WHEREAS, The City of Wharton and the Andrews Kurth, LLP. wishes to be bound by the conditions set forth in the agreement; and

WHEREAS, The Wharton City Council wishes to authorize the City Manager of the City of Wharton to execute the agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS as follows:

Section I. That the Wharton City Council hereby approves the Letter of Engagement between the City of Wharton and Andrews Kurth, LLP for bond counsel services.

Section II. That the City of Wharton and Andrews Kurth, LLP are hereby bound by the conditions set forth in the agreement.

Section III. That the Wharton City Council hereby authorizes the City Manager of the City of Wharton to execute the agreement.

Section IV. That this resolution shall become effective immediately upon its passage.


Councilmember Jeff Gubbels seconded the motion. All voted in favor.
