FEMA assistance is a supplement to private recovery efforts — not a substitute

- More than 373,000 Texas individuals or households have received financial assistance from FEMA since Hurricane Harvey, but FEMA cannot compensate survivors for all their losses or attempt to return their homes and property to their pre-disaster state.
 - o To protect yourself and your property, consider purchasing homeowners, renters, flood, and wind insurance. For more on these insurance types, visit https://go.usa.gov/xQ7px.
- The assistance FEMA's Individuals and Households Program (IHP) can provide is limited to \$33,300.
 - Home repair assistance makes a damaged home safe, sanitary and functional only. Assistance for damaged vehicles and household items will not replace or return them to their pre-disaster state.

Harvey survivors can partner with disaster case managers (DCMs) for recovery support

- DCMs provide a single contact person who can guide you through the recovery process, advocate on your behalf and help secure resources to address your unmet needs.
 - DCMs create a bridge to resources from state and community groups and volunteer organizations.
- Call 211 to connect with a DCM through Aug. 24, 2019. You do not need to be registered with FEMA.
- FEMA grants are funding more than 600 DCMs through the State of Texas Health and Human Services Commission and the nonprofit coalition National Voluntary Organizations Active In Disaster.

Protect yourself, your family and your property in your FEMA Manufactured Housing Unit (MHU)

- FEMA MHUs are designed to be safe and secure temporary housing solutions. As with all forms of housing, though, they are at risk for damage in severe weather.
 - o Never take shelter in an MHU during high winds or a flood.
 - o If you need to evacuate your MHU, leave your FEMA unit in place.
 - Disconnect electrical devices, but avoid standing in water while doing so. If you have time, place any important items on the highest shelves.

Texas Recovery Hurricane Harvey: Partnerships and Progress

All totals as of June 18, 2018

- 41 individual assistance counties designated
- 53 public assistance counties designated
- **41,500** square miles of land mass impacted (larger than Connecticut, Massachusetts, New Hampshire, Rhode Island and Vermont combined)
- 373,279 approved registrations
- 306 participating NFIP communities in declared areas
- \$1.1 billion in the six-month estimate for the hazard mitigation grant program
- 850 households in FEMA-funded hotels
- 18,876 survivors in temporary housing and innovative repair programs
- 1,278 requests for public assistance
- 12 million cubic yards of storm debris picked up
- 440 obligated projects for \$701 million
- \$13.78 billion in survivors' pockets
- \$1.62 billion in housing and other disaster-related expenses
- \$3.37 billion in U.S. Small Business Administration loans approved
- **\$8.79 billion** in NFIP advance payments and claims paid (estimate)
- \$23 million in disaster assistance unemployment
- 91,000 flood insurance claims

Direct Housing

The housing mission is federally funded, state-administered and locally executed. The State of Texas and local officials are leading the way in finding new solutions to help Texans impacted by Harvey.

• As of June 17: 3,291 applicants were housed through the Direct Housing program

Direct Housing maintenance questions: Survivors living in mobile homes and travel trailers provided by the Texas General Land Office/FEMA Direct Housing should call the maintenance number provided with their unit if they need assistance with the unit or appliances.
