Why won't the City tear down that house?

It is frustrating when there is a house in your neighborhood that is in disrepair and it seems like nothing is being done about it. The Supreme Court of Texas held in the case City of Dallas v. Stewart, that the owners of these structures have a right to constitutional protections. So, before a building can be ordered to be demolished, the City must follow very specific procedures to make sure the property owner's rights are protected.

These procedures include the preparation of a written report and recommendation, the property owner receiving written notice, a public hearing, an order being issued to repair or demolish, and the opportunity for the owner to appeal to the District Court. Although these procedures can be time consuming, because property rights are so important, the City of Wharton makes sure that it follows the law before ordering that a building be torn down. If a property owner does not demolish a structure after an order is issued, the City may do it, but the property owner is still responsible for the costs of the demolition. -Provided by Assistant City Attorney Amy Rod.

HOME Investment Partnerships Program

The City of Wharton is applying for funding through the HOME-DR and HOME Investment Partnerships Programs in an effort to assist our low income citizens improve their housing and reduce unsafe living conditions through replacement of substandard dwellings with new site-built homes. The City has not been approved for this program yet and is not accepting applications at this time. The City will be fully advertising and

notifying eligible applicants as soon as the application process can begin. The program requires applicants to currently own and occupy their home. The HOME-DR would apply to the homes that were affected by the flooding during 2016. The HOME program would be open to all City of Wharton residents that meet the requirements. Once accepted to the program home owners would be required to find alternative living arrangements for the construction period, approximately 5-6 months, and after construction would be required to live in the newly built home for a certain period of time for fund for-

Did you know?

At different times the community had a cotton oil mill, a sugar cane factory, gristmills, cotton gins, a milk processing plant and dairy, an ice plant, and numerous other industries.



The City of Wharton has applied to FEMA for multiple types of assistance under two separate funding opportunities. We are currently working with FEMA to provide additional information on all applications in order to get all areas of assistance approved and moved forward. The review process is timely and we are cooperating fully with all requests. As information becomes available from FE-MA we will be notifying citizens.

Painting of Curbs Downtown

The Mayor's Committee on People with Disabilities proposed a project to City Council after being advised by several citizens at different venues about the curbs and steps in the downtown area being hard to navigate and visibility of the multiple step heights being limited. The Committee researched painting a 2" strip on the top plate of the top step to help with visibility of the steps. After consulting the Downtown Merchants and Historic Committee it was determined that a color that would coordinate with the downtown area would be more aesthetically pleasing as well as also provide the necessary color differentiation. There will also be painting on the ramps around the square to avoid vehicular and pedestrian traffic from



having difficulty seeing them. This project is currently underway. The City staff has already begun pressure washing and then will begin the painting dependent upon the weather.

Downtown Sidewalks Coming to Completion

The Wharton Sidewalk Accessibility & Historic Streetscape Project Phase II is nearing completion. The City of Wharton applied and was granted funds to restore sidewalks in the downtown area. This allowed the City to bring sidewalks up to current ADA standards and renovate sidewalks that were in extremely poor condition allowing pedestrians to have a much safer way to travel. The current project is approximately 90% complete and is anticipated to complete the project near June 2017. The City is anticipating to apply for a new round of funding to continue to repair and add sidewalks to the City.

City of Wharton Levee Project



The City of Wharton City Council has moved forward with the plans to begin the Levee Project for the citizens on the West End of Wharton. The City is currently applying to the Texas Water Development Board for a loan to begin Phase 1 of the Levee project which will provide flood gates and a ledge to help alleviate some of the flooding that occurs on the West End from the Colorado River.

City Cancels General Election

The City of Wharton City Council canceled the May 13th, 2017 General Election after all candidates were unopposed. The final deadline for filing for place on the ballot was Friday, February 17th and when that date came and went the City Council took action to cancel the unneeded election. Each year City Council seats are up for election. On the even numbered years the even numbered seats and the Mayors position are on the ballot and on the odd numbered years the odd numbered seats are able to be sought after. If you are interested in running for the City Council, it is important to learn just what some of the requirements are.

- ⇒ You must be a qualified voter of the City of Wharton.
- ⇒ You must be a citizen of the United States of America.
- ⇒ You must be in compliance with all of the eligibility requirements for public office set out in the Texas *Election* Code.
- \Rightarrow You must not at the same time hold any other *elected* or appointed public office.

 \Rightarrow You must not have been convicted of a felony.

Texas law prohibits any person convicted of a felony from being a candidate for public office or holding any public office position. Felons who receive a full pardon are eligible to run for office.

Along with other requirements the one that is the simplest of all is the requirement to be registered to vote. Click on the button below to get all the information on registering to vote.


Time employed with the City of Wharton: Wade started his career with the City of Wharton in November of 2015.
