# What's the status of the Levee?

The City of Wharton received notice of their Flood Reduction Project being fully funded through the U.S. Army Corps of Engineers (USACE) in July of 2018. Since that time the City has been working closely with USACE to move forward with the \$74 million dollar project.

The project's funding came as part of nearly \$5 billion in funding that was designated for disaster recovery projects in Texas in the aftermath of Hurricane Harvey. Over the past 19 years the City has worked towards making the project shovel ready but tried to figure out ways to not place the multi-million dollar project on the backs of its citizens.

There are many questions that residents have on the construction of the levee and where the City has some answers, most will come from USACE, since it is their project. ### New Homes Awarded Through HOME Program

The HOME Investment Partnerships Program (HOME Program or HOME) is funded by the U. S. Department of Housing and Urban Development (HUD) with the goal to expand the supply of decent, safe, affordable housing. The Texas Department of Housing and Community Affairs (TDHCA) administers the HOME Program on behalf of the State of Texas, primarily in rural parts of the state.

In late 2017, City of Wharton residents Felix & Willie Formby applied for the HOME grant and after a several step process signed off on the grant paperwork in March of this year. The program will demolish their current

home and build them a new one in the upcoming months. There were over 73 applicants from throughout the City that submitted applications to participate in the program. Many of those whom applied are currently being notified of any outstanding paperwork for their appli-

Infrastructure/Construction:

#### HMGP – Warning System Mitigation(Siren Warning System)

Application submitted 10/13/16 under the DR-4269. This project was awarded 02/26/2018 and was accepted by the City Council on 03/26/18. Scope change approval was received February 1, 2019. Befco Engineering was awarded the engineering contract on May 13, 2019 and is in the process of preparing bid documents to go out for bid on equipment and installation.

### HMGP – Riverfront Park Soil Stabilization

Application submitted by GrantWorks Inc. in December 2018.

#### CDBG-DR - Infrastructure

Method of Distribution approved by GLO and HUD. City is designated to receive \$1,650,172.00 for infrastructure projects related to Hurricane Harvey. Project applications are in the process of being completed and submitted by GrantWorks for eligible projects. Applications will be submitted by Mid-June 2019.

#### HMGP - FEMA Shelter/Dome

HMGP Application submitted by WISD for FEMA Shelter/Dome. Project is under FEMA review and approval. There has been 1 request for information at this time.

## 2019-2020 CDBG – South East Ave. Sanitary Sewer Repairs

Application has been submitted and we are awaiting a response.

#### City of Wharton Levee Project – The Lower Colorado River Basin Phase I, Texas WHARTON FLOOD RISK MANAGEMENT PROJECT

The City of Wharton was notified that the Levee project was funded in the early part of 2018. City staff has been meeting with USACE staff monthly on items to be addressed. The current step is to contract an acquisition firm to start property acquisition for the first phase of the project. Once the firm is selected there will be a kickoff meeting, property owner meeting and citizen meeting. Acquisition is projected to be in progress by MidJune and completed by January

2020. USACE staff has indicated they will be ready for construction beginning Mid-year 2020. USACE is also in the process of contracting design firms for the remaining portions of the levee and will be working concurrently on this while phase 1 is in progress.

#### Housing:

#### **HMGP - Residential Elevation**

Application completed and submitted by GrantWorks Inc. in December 2019. One request for information has been received and responded to at this time.

#### HMGP – Reconstruction of 100 Homes

Application completed and submitted by GrantWorks Inc. in December 2019. One request for information has been received and responded to at this time.

### HMGP - Residential Mitigation (Elevation/Reconstruction of Homes)

Submitted on 1/20/17 under a second funding opportunity for DR 4272 and we are awaiting a response.

## TDHCA - HOME Reservation Participation

Applicants are currently being notified of any outstanding paperwork for their applications and are being asked to send this information in to finalize their applications. There were 73 applicants from throughout the city that submitted applications to participate in the program. There are currently 43 still working on applications. There are 7 applicants in title phase and 2 have been fully approved through TDHCA. 2 applicants have been awarded funding as of 2/16/19. 1 subject has declined the contract.

## GLO Community Development and Revitalization Program

The City Council procured GrantWorks, Inc. for administration and Jones & Carter for engineering.

#### **FEMA Pre-Disaster Mitigation Grant**

Call for application was made on August 11, 2017. The application was submitted 10/30/17 for the Nan Ya Lift Station and we are awaiting a response.

### **Protecting Your Home and Family**

A flood can happen at anytime, is your home and family protected?

You know flood insurance can help you recover from the financial consequences of flooding, but what do you need to know about flood insurance coverage? How do you know if you should purchase coverage for your structure, the contents of the home, or both? Like all insurance, flood insurance doesn't cover all items that could be damaged from a flood, so it's good to ask lots of questions.

Coverage for your building is designed to pay for the necessary repair or replacement of flood damaged structural components—for example, walls, floors, heating and cooling systems, large appliances, cabinets and or attached bookcases. The maximum building property coverage you can purchase is \$250,000.

Flood insurance contents coverage protects

your personal property, such as clothing, furniture, small appliances, bedding and other items in the home. The maximum contents coverage you can purchase is \$100,000.

To better understand how claims are paid, ask your agent to go over what is and is not covered, and discuss how your insurer estimates the value of your property.

For example, you will have limited building and personal contents coverage for your basement and for enclosures below some elevated buildings. This is an important topic to discuss with your insurer.

Method of Distribution approved by GLO and HUD. City is designated to receive \$1,693,784.00 for buyout/acquisition projects related to Hurricane Harvey. Project applications will be completed and submitted by Grant-Works for eligible projects. The application for buyouts will be submitted by June 1st.

#### 2016 CDBG-DR -

Notification of \$2,000,000 funding was received by city staff on February 4, 2019. This funding will assist homeowners with elevation, rehabilitation, and reconstruction of homes to address existing damage and mitigate future damage. GrantWorks is currently working with City staff and the GLO to develop criteria and applications.

#### HMGP – Critical Facility Generators

HMGP Application was submitted on 9/11/18 and we are awaiting a response.

#### FEMA – Temporary Housing Units

City staff is currently aware of 16 THU still in the City. Of those, 7 are working with the WLTRT for repairs or new housing and 2 are back in their homes waiting on FEMA to remove the units. The remaining 7 have unknown statuses at this time.

### Rebuild Texas – 2019 Preparedness Grant

Pre-Application was submitted on February 13, 2019 for AED Units for Public Facilities and Patrol Units and portable and mobile radios for the Public Works department. Project was awarded and City staff is in process of implementing.
